BE IT RESOLVED, that based upon the completion of the competitive selection process required by Section 121(d)(2)(A) of the Workforce Innovation and Opportunity Act, the scoring of the proposals submitted in response to the Request for Proposals and the recommendation of the Executive Committee, that Rockland BOCES (RBOCES) is hereby selected as the One-Stop Operator for the Workforce Development Board of Rockland County, Inc.

(WDBRC) for the operation and management of the Rockland County Comprehensive One-Stop Center (a/k/a Rockland Works) for the period beginning on July 1, 2024 and ending on June 30, 2025 with the option to extend the contract, based upon performance and funding availability, and that a mutually agreeable Memorandum of Understanding between the WDBRC and RBOCES shall be entered into for an initial term of three years, with an option for one, one-year extension thereof upon the determination of the WDBRC that the services being provided by RBOCES as the One-Stop Operator meet all required statutory and regulatory requirements and that sufficient funding exists for such extension.
